



PRIVACY POLICY

Healing Messages by Ellen, LLC (“Ellen Henry” or “Ellen”) operates www.EllenHenry.com (the “Website”). It is Ellen’s policy to respect your privacy.

The type of Information Ellen Henry collects

Ellen collects and process personally-identifying information, including name, phone number, and email address. Ellen’s purpose in collecting personally-identifying information is to provide you with services or otherwise respond to your requests.

Ellen may collect potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on the Website and non-personally-identifying information of the sort that web browsers and servers typically make available, like browser type, referring site, and the date and time of each visitor request. Ellen’s purpose in collecting potentially personally-identifying and non-personally identifying information is to better understand how visitors use the Website. Ellen may collect aggregated statistics about the behavior of visitors to the Website.

Gathering of Personal Information

You may choose to interact with Ellen on the Website in ways that require Ellen to gather personally-identifying information. The amount and type of information that the Website gathers depends on the nature of the interaction. In each case, Ellen collects and uses your personally-identifying information only as is necessary or appropriate to provide your requested services or otherwise fulfill the purpose of your interaction. You can always refuse to supply personally-identifying information, with the caveat that it may prevent you from engaging in certain Website-related activities.

Sharing of Your Information

Ellen may disclose personally-identifying information to Ellen’s employees and contractors (collectively, “Personnel”) only if such Personnel (1) need to know that information in order to process it on Ellen’s behalf or to provide services available on the Website, and (2) have agreed not to disclose it to others. Personnel may be located outside of your home country. Ellen may share this information with Wix, which hosts the Website and other event hosting platforms, such as Eventbrite (each, a “Platform”). By using the Website, you consent to the transfer of such information to them. Ellen will not rent or sell any of your information to anyone, ever.

Other than to Personnel and Platforms, Ellen will only disclose potentially personally-identifying and personally-identifying information in response to a subpoena, court order, or other governmental request, or when Ellen believes in good faith that disclosure is reasonably necessary to protect Ellen’s property, rights, third parties, or the public at large.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Ellen may use cookies to help identify and track visitors, their usage of the Website, and their Website access preferences. Website visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using the Website, with the drawback that certain features of the Website may not function properly without the aid of cookies.

How Your Personal Information is Stored

Your information is securely stored both within a multifactor secure site and also using cloud-based security software.

Ellen Henry will keep your name and contact information while you are subscribed to the mailing list or the Website. If you wish to delete your data, you can unsubscribe from the newsletter or email Ellen Henry directly.

GDPR Data Protection Rights

If you live in a country that is subject to GPDR, protection laws provide you certain rights, including:

Access. You have the right to ask Ellen for copies of your personal information.

Rectification. You have the right to ask Ellen to rectify personal information you think is inaccurate and to complete information you think is incomplete.

Erasure. You have the right to ask us to erase your personal information in certain circumstances.

Restriction of Processing. You have the right to ask Ellen to restrict the processing of your personal information in certain circumstances.

Objection to Processing. You have the right to object to the processing of your personal information in certain circumstances.
